FAHS Boys and Girls Soccer teams going to counties

On 16 October, a cold Tuesday night, the Fleetwood boys' and girls' soccer teams traveled to Tulpehocken High School to compete in the county semifinals. The boys started at 5:30 and dug right in. They scored two goals with twelve minutes left in the first half and scored a late first half goal to make it 3-0 at the end of the half. Sam Schappell, Fleetwood Tigers' goalie, came up with a big penalty kick save to keep the momentum on Fleetwood's side in the first half.

'I just knew I couldn't get cold feet, that I had to pick a side. Luckily I picked the right side and was able to make an easy save," goalie Sam Schappell said. They didn't allow halftime to affect their play, and scored three more goals to finish the game 6-0.

The girl's team followed, taking on Berks Catholic. Fleetwood went against Berks Catholic twice in the regular season, with Berks Catholic winning both meetings.

Fleetwood controlled the first half, keeping a lot of possession and getting shots on goal but failing to execute. At the end of the first half, no goals were scored by either team. The second half stayed the same, with Fleetwood keeping most of the possession but failing to execute, which led to a tied game at zero at the end of

Overtime did not take too much time. Leilah Sallee brought the ball down the left side of the field and took a shot on goal that was deflected by the Berks Catholic keeper. The ball rolled right into the feet of Fleetwood junior Faith Herndon, who had a wide open net. Herndon buried the ball in the net, winning the game for the Tigers and sending them to the county Finals for the third time in the last four years.

This was also the first time since 2009 that both boys' and girls' soccer teams both made it to the County Championship. Both teams will take on Wilson at Exeter. Both teams look to carry the momentum from the semifinals and bring home the County Championship.



Fleetwood Area School District Hosts Community Forum about Buildings

The Fleetwood Area School District hosted a community forum on 11 October 2018 to discuss information presented regarding enrollment and demographics in the district. The district brought in Charles Watters of the Pennsylvania Economy League and James Thompson of Thompson Associates Architects and Planners to present information from studies they per-

The district held this community forum to inform members of the community so they can participate and help in future decisions.

"The purpose of the forum was to inform the community and to solicit input from the group. My perspective is that informing and collecting input from the community is a critical step in any major decision," superintendent of school Dr. Greg Miller said.

There were many Fleetwood community members present, filling up the Willow Creek cafeteria. Their input will be considered in future decisions by the school board.

The first speaker, Charles Watters, presented his findings. He and other members of the Pennsylvania Economic League projected future enrollment trends in Fleetwood. To do this they reviewed populations and births in the town. They also took a look at housing markets, relationships, and other key indicators. With all

this information, Watters was able to generate advanced models and projections to assess future enrollment and trends for the Fleetwood Area School District

The whole purpose of Watter's presentation was to inform the community. Similarly, James Thompson presented information regarding the capacity and state of the buildings under the district's ownership.

After the two presentations, the groups of community members responded to three essential questions. Their answers were written down and will be used as input for future decisions and meetings

"Technically, the final say of how we proceed is up to the school board. Therefore, the community forum and input collected from them is critical to inform the board of what the community is thinking on this topic. During the November 8th community forum, we will be revisiting the ideas provided and will work with those in attendance to try to drill down to an overarching perspective from the community." Dr. Miller said.

The community's input is essential and valuable to the school board and Dr. Miller, and they look forward to the next community forum on November 8th.

Fake National Honors Society Scams Students with Unnecessary Entrance Fees

A misleading honor society is scamming high school students across the country. The National Society of High School Scholars misleads students into thinking they are joining the National Honor Society and asks them to pay a \$60 membership fee.

The NSHSS sends a letter of invitation over the summer to high school students. The letter includes their school name on the invitation even though there is no correlation. This confusion leads students to think it's a school organization, but it is not.

There have been several complaints from students and parents that they have never heard from the organization again once they sent the \$60. NSHSS promises students scholarship opportunities, and while this is true, there is a catch: you have a very small chance of winning these scholarships.

The fact of the matter is, high school students do not have to pay money to actually get into their school's Honor Society. It is earned, not bought. The NSHSS is tricking young adults into paying for a title and taking away real accomplishments.

Even though there are scholarship op-

portunities, a person should never have to pay to apply. There are plenty of scholarships that are available without a fee . Most students think that this society will help on their college applications, but it will not. Colleges want to see what you like to do, not what you will pay to be apart

"This is an organization that asks students to be a part of it," Karen Long, the University of Miami's assistant Vice President of admissions office, said.

South Carolina Resident Wins Mega Millions

The Mega Millions jackpot was what benefit from selling the winning ticket. He will every ambitoius American citizen was praying

Held at \$1.537 billion dollars, a resident of South Carolina woke up very lucky on 24 October 2018.

The winning ticket was sold at the KC Mart #7 in Simpsonville, in the northwestern region of the state. The winning six numbers were announced and drawn on 23 October

Lottery officials stated the jackpot is nearly \$50 million less than the estimated amount of \$1.6 billion.

The winning numbers included the following: 5 - 28 - 62 - 65 - 70, with a Mega Ball number of 5.

Mega Millions officials stated that the estimated cash option to take a one-time lump -sum payment instead of annual payments over 30 years is \$878 million before taxes.

C.J. Patel, the owner of the KC Mart #7, said "it was good for the community" that the ticket was sold there. C.J. said he hopes the winner will stay local. Mr. Patel will also

receive \$50.000 once the ticket is claimed.

Tony Cooper, chief executive of the South Carolina Education Lottery, made a statement to the winner, saying, "Take a deep breath." Cooper also urged the winner to meet with financial and legal advisers before making any huge decisions. The winner or winners have 180 days to claim the winning ticket. The winner has not come forward yet.

Voyager 2 Leaves Solar System

Mankind's second object to enter interstellar space finally did so after forty-one years. Voyager 2, designed by the Jet Propulsion Laboratory, launched 20 August 1977. Its mission was to observe the Jovian planets. Voyager 2's twin, Voyager 1, launched 16 days later and became the first man-made object to enter interstellar space. Aboard the probes, there is a time capsule containing information about us as a species for aliens or future humans to find. The time capsule is called the Golden Record because it is an actual phonograph record.

The contents of the Golden Record are of information about the male and female anatomy, a photograph demonstrating how humans eat, drink, and lick, a photograph of a woman in a supermarket, as well as audio recordings of wildlife, music, and children saying, "Hello from the Children of planet Earth." Furthermore, to show that humans are an advanced civilization, a model of a hydrogen atom was etched on.

How do we know that Voyager 2 is leaving the solar system? It turns out that outer space is a very irradiated place. Astronomers are monitoring the amount of cosmic radiation hitting the probe. They have found that the radiation levels are similar to Voyager 1 when it was on its way out of the solar system.

People wonder what Voyager 2 will find

in interstellar space. "I think it's gonna find a black hole, fall into the event horizon, and we'll never hear from it again," sophomore Andrew

Unfortunately, Voyager 2's on-board nuclear reactor will run out of power in ten years. This does open up another topic. What will find Voyager 2? Could it be aliens? Perhaps future humans? The probe finding future humans is not too out of the question. In 296,000 years, Voyager 2 will arrive at the Sirius solar system. It is possible for human life to be there by the time the probe arrives.

In 150,000 years, it is estimated that human technology will be advanced to the point where interstellar travel is incredibly fast. Humans can launch from Earth and land in Sirius in about three months. At that speed, they can pass Voyager 2 and still have another 150,000 years to build up a civilization by the time Voy-

With this concept in mind, astronomers are debating when it will be ethical to send humans to colonize other solar systems. Starships meant to house multiple generations of people could be overlapped.

Migrant Caravan Seeking Asylum

Thousands of people from Central America are demanding asylum in the United States. The migrants' journey began on 12 October 2018 in San Pedro Sulas, Honduras. The caravan started with only 160 people, but that did not last for long.

As the three caravans were migrating up north, thousands of people joined, bringing their friends and loved ones. The caravans contain people mainly from Honduras, Guatemala, and El Salvador.

The migrants have traveled about 20 miles per day by foot, but some have hitched rides by cars or trucks. The migrants' goals are to seek better opportunities in the United States or Mexico. There are no jobs in their countries and they want a change for their families.

"The caravans are made up of some very tough fighters and people. Fought back hard and viciously against Mexico at Northern Border before breaking through. Mexican soldiers hurt, were unable, or unwilling to stop caravan. Should stop them before they reach our border, but won't!" President Trump tweet-

The migrants attacked Mexican police by throwing rocks at them. Trump wants more border patrol and about 15,000 armed guards to prevent this abuse from happening to the mili-

As of 1 November 2018, six migrants have sued Donald Trump and his administration for violating their constitutional rights. The law states that anyone can claim asylum who was born outside the United States. The migrants do have the right to due process.

Donald Trump is allowing asylum seekers to live in tent cities to be able to get a court date and then become lawful citizens. He wants to detain them for the time being. Democrats argue this goes against their constitutional

Illegal Fetus Remains Found Stored in Boxes at Funeral Home in Detroit

my 41 ½ years on the force, ever," one police officer said.

Sixty-three fetus and infant remains were discovered improperly stored in boxes and freezers at Perry Funeral Home in Detroit, Michigan, just one week after eleven others were found at another Detroit funeral home in a drop-down ceiling.

Thirty-seven of the sixty-three remains were found in unrefrigerated boxes, while the other twenty-seven were found in a freezer. Some of these remains have been deceased for up to three years.

Perry Funeral Home's mortuary science license has since been revoked. Generally, funeral directors have to supervise a body's final disposition within 60 days of receiving it. If this is not enforced, it is considered a misdemeanor, punishable by up to 90 days in prison. If nothing is done after 180 days, it is then considered a felony, punishable by up to 10 years in prison. Charges have yet to be filed against the funeral home.

Perry's lawyer, Joshua I. Arnkoff, said

"I have never seen anything like this in the allegations involve "unclaimed infant remains" from local hospitals. He doesn't believe any involved families paid for funeral

> "Perry Funeral Home has been serving the Detroit community for decades and has been a reputable, reliable, and caring member of the community. The allegations being made through the press are inaccurate," Arnkoff stated

> These discoveries come just one week after eleven fetuses and infants were found in a drop-down ceiling in another Detroit funeral home. Cantrell Funeral Home was raided on 12 October, six months after they were shut down for multiple violations, including improper storage of embalmed bodies, two of which were in advanced stages of decomposi-

"I am committed to get to the truth... This is deeply disturbing," Police Chief James Craig said. "This may be larger than we know.'

Florida Middle School Girls Plan Cannibalism on Classmates in Failed Attempt

Two Florida Middle School girls, aged 11 and 12, attempt to perform a Satanic ritual in their school's restrooms. The unnamed girls were hoping to kill upwards to 15 to 25 students. They later said in an interrogation that even one victim dead was satisfactory.

The girls planned on stabbing their victims, drinking their blood, and eating their flesh. Police found multiple knives, a pizza cutter, and a knife sharpener on them. To dispose of the victims' bodies, the girls said in texted correspondence, "We will leave body parts at the entrance and then we will kill ourselves." When asked their reasoning behind the planned attack, the girls said they wanted to be worse sinners so they could be closer to

How do children get these ideas? For the girls case, they spent the weekend together watching horror movies. Fleetwood's psychology teacher, Mr. Weiss was asked how the movies impacted the planned attack.

"Horror movies cannot be blamed for the entire attack. Many people watch horror movies all the time and do not engage in this type of behavior. If a person is well adapted in life, they can certainly make the distinction between what is morally, socially and ethically correct and what is not. Did the binge watching of horror movies trigger this maladaptive behavior? My guess is that it probably did but there are additional reasons as well," Weiss went on to say in an email.

If the girls were found with different weapons such as firearms, the public outlook on this situation would be very different. The fact of the matter is, there was no security. Most people can smuggle just about anything into a school building. More security in schools should be the topic to discuss and not necessarily weapon bans. What happened at this Florida middle school is a classic example of if you see something, say something.

Climate Change Continues Encroachment

In just over a decade, if the human population does not change its ways, the effects of climate change will become irreversible. Reports say the world's coral reefs will die off as soon as 2040. This is within many of the current popula-

Climate change has been an increasingly prominent issue within the past decade. As more research shows the negative effects of so many everyday activities and products that are commonly used by the public, drastic efforts needs to be taken in order to keep the effects of climate change at bay.

"Taken as a whole, the range of published evidence indicates that the net damage costs of climate change are likely to be significant and to increase over time," NASA said.

Activities such as driving, deforestation, and burning fossil fuels are one of the leading man-made causes for global warming. The meat industry also plays an enormous cause of climate change.

"The U.S. Environmental Protection Agency has shown that animal agriculture is glob ally the single largest source of methane emissions and that, pound for pound, methane is more than 25 times as effective as carbon dioxide at trapping heat in our atmosphere," People for The Ethical Treatment Of Animals said.

The meat, dairy, and egg industry account for more than 65% of the greenhouse gas known as nitrous oxide. Reducing animal consumption is one of the single most effective ways to reduce the effects of climate change, according to scientific analysis.

Before Kavanaugh could even make it to the Supreme Court, sexual assault allegations were made against him. Palo Alto University Professor of Psychology, Christine Blasey Ford, contacted The Washington Post's tip line with allegations that he sexually assaulted her in high By Morgan Althouse school during the 1980s. Two other women accused him as well, but he denied all accusa-

At a rally in Mississippi on 2 October 2018, Trump presented his own version of Ford's testimony to the Senate Judiciary Committee: "Ford: 'I had one beer.' Them: 'How did you get home?' Ford: 'I do not know - but I had one beer. That is the only thing I remember."

Trump's paraphrased version of the

testimony was not completely accurate to the real testimony.

After the allegations, Brett said the last two weeks had ruined his life.

"My family and my name have been totally and permanently destroyed. I was not at the party described by Dr. Ford. This nomination process has become a national disgrace. Since my nomination in July, there has been a frenzy on the left to come up with something anything - to block my confirmation," Kavanaugh said.

After all of this, the United States senate voted 50-48 to confirm judge Brett Kavanaugh. This handed Donald Trump a major victory and America a bench that is expected to lean to the right.

'I do not believe that Kavanaugh assaulted anyone because there has been no prime evidence for me to believe that it happened. The witnesses called to the stand did not even know who he was, and said he was never at that party. They only spoke out now because they want to diminish his name and do not want him on the court because they feel that it would be conservative bias. Ford does not remember anything because she is lying and poorly fabricated the story in an attempt to ruin Kavanaugh," FAHS junior Nathan Nahr-
